SCHEDULE

IN EXERCISE of the powers conferred on the Director of Posts and Telecommunications by section 4 of the Post Office Act, the following Regulations are hereby made with the approval of the Minister —

- Citation and commencement 1. These Regulations may be cited as the Post Office (Postage, Telegraph and Miscellaneous Charges) Regulations, 1980, and shall be deemed to have come into operation on 1st March, 1980.
- Prescription of tariffs 2. The charges listed in the Schedule are hereby prescribed in respect of postage, telegraph and miscellaneous charges.
- Revocation of S.I. 55 of 1971 3. The Post Office (Postage, Telegraph and Miscellaneous Charges) Regulations, 1971, are hereby revoked.

A charge for the telegram of advice at the ordinary or letter telegram rate as the remitter prefers. The remitter is allowed, on paying for additional words required, to add to the telegram of advice any short communication for the payee, not exceeding twelve words.
